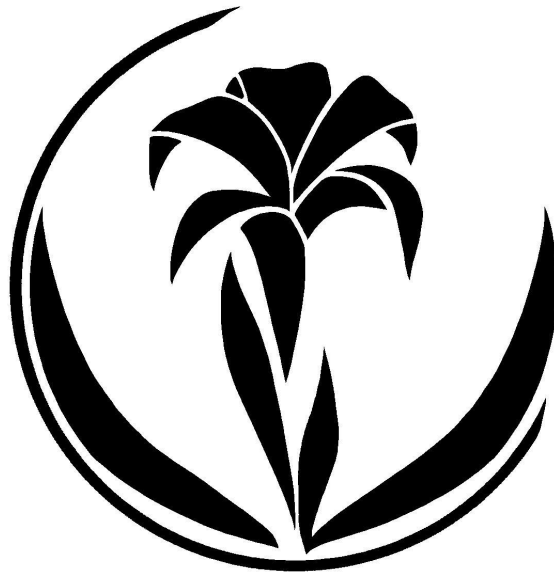

### **\*GENERAL INFORMATION; DISCLOSURES**

However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Certain funeral services may be provided off premises by other funeral services providers. This list does not include prices for certain items that you may ask us to buy for you such as, cemetery or crematory services, death certificates, flowers and newspaper notice. The prices for these items will be shown on your bill as cash advance items.

**\* It is the policy of Craigsville Funeral Home to charge for the cash advance items if they are added to the funeral bill and not paid for at time of arrangements.**

### **OUR PAYMENT POLICY**

Payment is expected when services are rendered unless other arrangements are made in advance.

All family members involved, such as spouse, children, etc. must sign the funeral service contract.

### **ACCEPTABLE PAYMENT METHODS**

- A. Cash at the time of arrangement.
- B. Check at the time of arrangement.
- C. Credit Card at the time of arrangement.
- D. Insurance must be proven in force at the time of arrangement. Beneficiary must sign a Deed of Assignment to the funeral home as well as the funeral service contract.

- F. With special consideration the family may be allowed to pay 75% of the total funeral at the time of arrangement. The remaining balance will be due in 30 days. If the balance is not paid, a monthly fee of 2% of the unpaid balance will be added to the total due.

### **PROFESSIONAL SERVICES OF FUNERAL DIRECTOR & STAFF      **\$2200.00****

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burials and forwarding or receiving remains.

Our fee for the funeral director and staff include, but not limited to, staff available to respond 24 hours a day to initial request for service, care and custody of the body, arrangements and documents, consents and permits, recording vital statistics, filing insurance forms for up to three companies, preparation and placements of obituary notices, general administration and record keeping, filing of governmental forms, death certificates, and social security forms, coordination with third parties providing other portions of the funeral e.g. cemetery, crematory, clergy and others, and follow up attention to related details after the service. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative cost, equipment and inventory expense, professional licensing, infectious waste management, and taxes.

### **PREPARATION OF REMAINS – EMBALMING**

Embalming is not required by law. Embalming may be necessary, however, if you select certain arrangements such as funerals with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### **FUNERAL HOME FACILITIES**

A. Use of facilities and staff services for **visitation** and / or viewing (per day or portion thereof) at our facility or another location. Our services include setup of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during the visitation, and use of visitation room, parking lot and other funeral home facilities. **\$325.00**

**A.A. Visitation one hour prior to services** **\$250.00**

B. Use of facilities and staff for **funeral ceremony** or for the transfer and services at another facility. Our services include coordination of the funeral arrangements, supervision of the funeral, equipment and staff to attend the service. **\$350.00**

C. Use of facilities and staff services for **memorial service** (without body). Our services include coordination of the memorial services arrangements, supervision of the memorial service, as well as facilities, staff, and equipment to attend the service. **\$350.00**

D. Equipment and staff services for **graveside services**. Our services include accompaniment of remains to cemetery, supervision of the graveside service, preparing encased remains for transportation and flowers, staff to attend service, tent and chair setup and supervision of burial, without funeral ceremony. **\$350.00**

**D.A. Graveside following funeral ceremony** **\$175.00**

E. Shelter of remains per day **\$50.00**

F. An additional overtime fee will be applied to all services conducted on weekends or national holidays. Not to be applied more than once. **\$195.00**

G. Use of facilities and staff for **private viewing**. Our services include use of visitation room and staff supervision for private viewing of unembalmed body (not to exceed one hour). This charge is set for identification purposes. **\$150.00**

#### **FORWARDING REMAINS TO ANOTHER FUNERAL HOME**

This charge includes removal of remains, necessary services of staff, embalming, minimum shipping container, and necessary authorizations. This does not include transportation to airport, visitation, rites or ceremonies prior to forwarding the remains, or merchandise.

### **IMMEDIATE BURIAL** **\$2325.00 – \$11,700.00**

Our charge for an immediate burial, which must occur within 48 hours after death, without any attendant rites or ceremonies, include removal and shelter of remains, local transportation to the cemetery, necessary services of staff and authorization.

- A. Immediate burial with casket provided by purchaser **\$2325.00**
- B. Immediate burial with alternative container\* at \$100.00 **\$2425.00**
- C. Immediate burial with Agean casket **\$11,700.00**

### **DIRECT CREMATION** **\$2850.00 – \$7640.00**

Our charge includes removal of remains, handling all paperwork and authorizations, transportations to and from crematory, medical examiner's fees, crematory fees and the services of our staff. This charge does not include the cost of any urn or cremation urn vault. State and local laws do not require a casket for direct cremation. If you want to arrange a direct cremation you can use an alternative container. Alternative containers encase the remains and can be of material like fiberboard or composition materials (with or without an outside covering). The containers we provide are heavy cardboard containers.
